**ORDER ON CONTEMPT AND TO INCARCERATE DEFENDANT**

The foregoing matter came before this Court on a regularly scheduled calendar and the Defendant was properly served with a copy of Plaintiff's Petition and notice of this hearing.

A Final Order On Contempt in Civil Action File No. 11-1-3210-28 was entered by this Court on May 12, 2011, whereby the Defendant was found to be in willful contempt of this Court.

With regard to said Order of this Court:

Defendant was to pay Plaintiff the sum of \$10,000.00 of his child support arrearage within thirty (30) days of said Order, Defendant has failed to comply with this Court's Order as of this date.

Defendant was to pay the sum of \$1,000.00 per month toward his child support arrearage to Plaintiff in addition to his regular monthly child support payments until such time as the arrearage was paid in full. The Defendant has failed to comply with this Court's Order as of this date.

Defendant was Ordered to pay Plaintiff's attorney's fees in the amount of \$3,500.00, payable at the rate of \$500.00 per month. Defendant has failed to comply with this Court's Order.

Defendant was Ordered to pay Plaintiff's expenses of having him served with process of service in the amount of \$130.00 within 60 days of the Order. Defendant has failed to comply with this Court's Order.

Defendant was Ordered to provide written certification of an in force life insurance policy for the benefit of the parties' minor child in the amount of \$126,000.00. Defendant has failed to comply with this Court's Order.

Defendant was Ordered to pay to Plaintiff the amount of \$65.00 in unreimbursed medical expenses for the parties' minor child. Defendant has failed to comply with this Court's Order.

Upon hearing testimony and evidence on Plaintiff's Petition For Attachment For Contempt (CAFN 11-1-6204-29), Defendant has failed to pay his child support payments which were due on May 20, 2011, June 4, 2011, June 20, 2011, July 4, 2011, July 20, 2011, August 4, 2011, August 20, 2011, September 4, 2011, September 20, 2011, and October 4, 2011, in the aggregate amount of \$6,550.00.


The Court hereby finds as follows:

That Defendant has failed to purge his willful contempt, and that he has continued in a state of willful contempt by his additional failure to make child support payments which were due on May 20, 2011, June 4, 2011, June 20, 2011, July 4, 2011, July 20, 2011, August 4, 2011, August 20, 2011, September 4, 2011 and September 20, 2011. The Court awards the Plaintiff an additional \$3,500.00 in attorney's fees and \$345.00 for costs in

serving Defendant in Civil Action File No. 11-1-6204-28: The Court Orders that the Sheriff of Cobb County, Georgia take the Defendant into custody where he is to be confined in the common jail of Cobb County, Georgia, held, and remain there until such time as he purges his contempt by paying the total sum of \$33,980 .00, (broken down as follows: child support arrearage in the amount of \$26,140.00, total attorney's fees in the amount of \$7,000.00, medical reimbursement in the amount of \$65.00, costs of procuring service on the Defendant in the amount of \$475.00) in certified funds to Plaintiff through her counsel of record or until such further order of this Court.


Further, within thirty (30) days of his release from jail Defendant is to provide Plaintiff with written certification that a life insurance policy for the benefit of the minor child in the amount of \$126,000.00 has been procured with Plaintiff as named trustee.
